Healthcare as we know it is being rewritten by the consumer, technology and data. Mr. Gaboriault will share his insights and experiences at Christiana Care Health System on some of the structural and nuanced changes that are driving continuous digital innovation in Healthcare.

Randy Gaboriault, is CIO and Senior Vice President of Innovation and Strategic Development at Christiana Care Health System. He chairs the Delaware Health Information Network, the nation's first health information exchange. With global experience spanning high-reliability industries from aviation to automotive, industrial and medical devices, Gaboriault is a non-profit director for Tech Impact and advisor to Safeguard Scientifics. Distinctions for innovation include recognition from *CIO* magazine, Computerworld; *Information Week* "Twenty Great Ideas to Steal"; HealthTech Research Alliance & Council, nominated as Healthcare Innovator of the Year; *Becker's Hospital Review* and 2016 "Most Wired Hospital" award. *CIO* Magazine Editor in Chief, identified Randy as, "an exceedingly rare triple threat CIO: equally talented at creating, managing and selling." Embracing the Consumer Perspective in Health Information Exchange

Abstract

Our presenters are advocates active in their own care and the care of loved ones. They will share personal stories of their interaction with the healthcare system to illustrate challenges -- especially in continuity of care -- that patients and families face on a daily basis. Their encounters with healthcare and resulting recommendations demonstrate ways that the healthcare system and its information tools could dramatically improve the patient-and-family experience. Their perspective holds insights for: health information exchange among hospital systems, primary care providers, and insurers; for the critically important issue of transitions of care; for medication management; and for other issues that fundamentally affect the lives of patients and their caregivers. Problems presented are coupled with examples of innovative activity in the Delaware Valley to close these gaps.

Connected Care - Theory vs. Reality

Abstract

Health systems, insurance companies and direct to consumer companies are jumping into telehealth and competing for the same pool of patients using digital technologies. Many are establishing formal corporate structures and/or hiring physicians to conduct virtual healthcare visits as their time allows. In theory this all sounds good, but in reality there are still many challenges to making a connected care program work. This talk will address the realities related to operational, legal and regulatory issues impacting connected care today.

Joe Tracy

Vice President, Connected Care and Innovation Lehigh Valley Health Network

Mr. Tracy has been working in the area of connected care and innovation since 1993. He currently oversees the Lehigh Valley Health Network's Center for Connected Care and Innovation, which provides more than 31,000 virtual clinical encounters a year.

Tracy currently serves as the Co-Chair of the Pennsylvania Telehealth Advisory Committee and sits on the Advisory Boards for the Mid-Atlantic Telehealth Resource Center (MATRC) and the University of Pittsburgh's Rehabilitation Engineering Research Center on Telerehabilitation. He is also a past President of the Center for Telehealth and e-Health Law and a Past Chair of the American Telemedicine Association's (ATA) Institutional Council.

In 2013, Tracy was one of three members of the Lehigh Valley Health Network to accept the American Nursing Credentialing Center's Magnet Prize for "Telehealth Services." In 2003, Mr. Tracy accepted the ATA President's Award on behalf of the Missouri Telehealth Network and in 2006 he accepted ATA's Leadership Award for his individual contributions to the field of telehealth.

Digital Health and Innovation in the Commonwealth



Lauren Hughes, MD, MPH, MSc, FAAFP Deputy Secretary for Health Innovation Pennsylvania Department of Health

Dr. Hughes is a practicing family physician and Deputy Secretary for Health Innovation in the Pennsylvania Department of Health. Prior to joining the Department, she was a Robert Wood Johnson Foundation Clinical Scholar at the University of Michigan where she studied health services research. Hughes holds degrees in zoology and Spanish from Iowa State University, an MPH in health policy from The George Washington University, and a medi-

cal degree from the University of Iowa. Dr. Hughes served as the national president of the American Medical Student Association for one year prior to completing her residency at the University of Washington in Seattle. She has volunteered through AmeriCorps in a federally qualified health center, worked for Iowa Senator Tom Harkin, and studied medicine and health systems in Brazil, Sweden, Tanzania, and Botswana. Dr. Hughes has also been a visiting scholar at the Robert Graham Center, ABC News Medical Unit in New York City, the Center for Medicare and Medicaid Innovation, and The Commonwealth Fund. In 2015, she was named a regional finalist in the White House Fellows program, and in 2016, a recipient of the Women Leaders in Medicine Award from the American Medical Student Association and the Early Career Achievement Award from the University of Iowa Carver College of Medicine.

The Health Enterprise Zone: How will this Impact the Residents of North Philadelphia?

Abstract

The Health Enterprise Zone is a new collaboration between the Pennsylvania Department of Human Services, Department of Education, the City of Philadelphia, area hospitals and other stakeholders aimed at providing better health care by increasing access, improving quality, and reducing health disparities for residents of North Philadelphia through innovative community-based approaches to health care such as providing employment opportunities. Nearly 300,000 Medicaid recipients accounting for 13% of Pennsylvania's Medicaid population reside in the North Philadelphia zone. These families are more likely to experience deep poverty that affects not only their health but also their education, employment and income.

Bill Ryan

Assistant VP of Government Affairs Einstein Healthcare Network

Drawing on more than 20 years as a campaign operative and consultant, Mr. Ryan serves as Assistant Vice President for Government Relations and Public Affairs at the Einstein Healthcare Network.

Ryan is responsible for overseeing federal, state and local lobbying efforts at Einstein and was active with the passage of both the Philadelphia and Pennsylvania Hospital Assessments, legislation which provided more than \$500 million of additional funding for hospitals across Pennsylvania.

In addition, Mr. Ryan was part of the lobbying team that helped create Pennsylvania's DSH allocation for OB services.
